#### **Prof. Peter Zweifel**

Prof. Peter Zweifel is a Professor Emeritus of Economics, Department of Economics, Univer-sity of Zurich (Switzerland). He has been a visiting professor to the University of California at Santa Barbara, the Wharton School of the University of Pennsylvania, Duke University, Whitwatersrand University in Johannesburg (South Africa), the African Institute of



Mathematical Science in Muizenberg/Cape Town (South Africa), Curtin University and University of Western Australia in Perth, Australian National University in Canberra, University of New South Wales in Sydney, Fudan University in Shanghai, and the Diplomatic Academy in Vienna. He received his M.A. (1969) and Ph.D. (1973) in economics from the University of Zurich, followed by a stay as an honorary fellow with the Economics Department of the University of Wisconsin (Madison). Prof. Zweifel is co-author of the textbooks Health Economics, Insurance Economics, and Energy Economics and has also published more than 100 articles in refereed journals. From 1997 to 2006, he served as a member of the Swiss Antitrust Authority and from 2006 to 2010, as an advisor to the World Bank. Together with Mark Pauly (Wharton School), he is the founding editor of the International Journal of Health Economics and Management.

#### Valentin Brodszky

Valentin Brodszky MD, MSc Econ, PhD, Habil, graduated as a medical doctor from the Semmelweis University of Budapest in 1999. After medical school he started to study at Corvinus University of Budapest Faculty of Business Administration. He graduated as an economist in 2005. He has defended his PhD at Semmelweis University in 2009 and his research topic was quality of life in patient with chronic inflammatory disorders. Since 2012 he is an associate professor at Department of Health Economics Corvinus University of Budapest.



His scientific research focuses on evidence based medicine, health economic modelling and technology assessments. His publication activity including 45 English and 37 Hungarian publications, 14 book chapters and 89 published conference abstracts.

#### Prof. Márta Péntek

Márta Péntek MD, PhD, Habil, graduated as a medical doctor from the Semmelweis University of Budapest in 1989 and specialized in rheumatology and physiotherapy in 1997. She has defended her PhD at Semmelweis University in 2008, her research topic was disease burden and quality of life of patients with rheumatoid arthritis. She defended her habilitation at the University of Pécs in 2013. Since 2015, she is full professor at Department of Health Economics Corvinus University of Budapest.



Her scientific research focuses on cost-of-illness, health-related quality of life, patients' perspectives in health economic evaluation and health care. Her publication activity includes 62 scientific papers in peer-reviewed English language journals and 48 in Hungarian journals, the number of publications in top 25% journals is 56 and the number of independent citations is 547, Hirsch Index 17. #### Prof. László Gulácsi

László Gulácsi works as a Professor and Head, Department of Health Economics, Corvinus University Budapest, Budapest, Hungary. (<a href="http://hecon.uni-corvinus.hu">http://hecon.uni-corvinus.hu</a>) He is the head of the Hungarian Office for Health Technology Assessment (HunHTA).

By profession he is a physician (Debrecen Medical University), having university degrees of programming mathematics (Kossuth Lajos University of Arts and Sciences), mathematical economics and sociology (Corvinus University of Budapest) and health economics (University of York).



He received PhD degrees from the Medical University of Amsterdam, Corvinus University of Budapest, Semmelweis Medical University Budapest and from the Debrecen Medical University. He is qualified in social medicine.

He is a member of the Editorial Board of the European Journal of Health Economics (EJHE), the Value in Health Regional Issues (ViHRI) Editorial Advisory Board, the Editorial Board of the Hungarian Medical Journal, and the Society and Economy, Academic Editor PLOS ONE Editorial Board, Health Academy, University of Pécs, Clinical Dermatology Open Access Journal, Associate Editorial and peer reviewer of Dove Medical press journals.

He is the past President of the Health and Health Care Economics Section of the Hungarian Economics Association.

To date (April 2017) he (co)authored 278 scientific articles in peer reviewed journals, published 12 books, 66 book chapters and on health economics, public health, health technology assessment, health policy and quality improvement. He has successfully supervised the completion of 6 PhD thesis and in the process of supervising another 4.
